Sub: Award to best schools under Non- NPEGEL Scheme 2011-12.

Under Non-NPEGEL scheme for the year 2011-12 there is an allocation of Rs. 10,000 per Non-NPEGEL block for award to best one school. The norms for the implementation of this activity as approved are as under:-

A committee under the chairmanship of BEO having two senior most Principal of the block as members would select the best school from among the schools of the block. The objective is to have healthy competition among the schools under each block in regard to GER, Cleanliness, gardening, environment, general performance of students, promotion of girl education, meena manch activities etc.

The selected school should be other than the best school selected last year. Criteria for selection of the best School will be based on the performance in respect of six indicators which are as under:

1. (a) Percentage of enrolment of girls in comparison to girls population in the relevant age group in the catchment area of the respective schools

(i)	Above 99%	-	50 marks
(ii)	95-99%	-	40 marks
(iii)	85-95%	-	30 marks
(iv)	75-85%	-	20 marks
(v)	Below 75%	-	10 marks

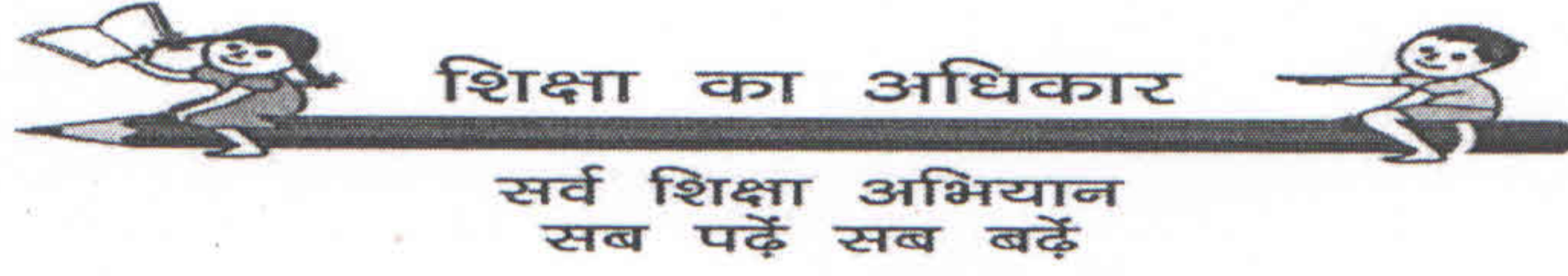
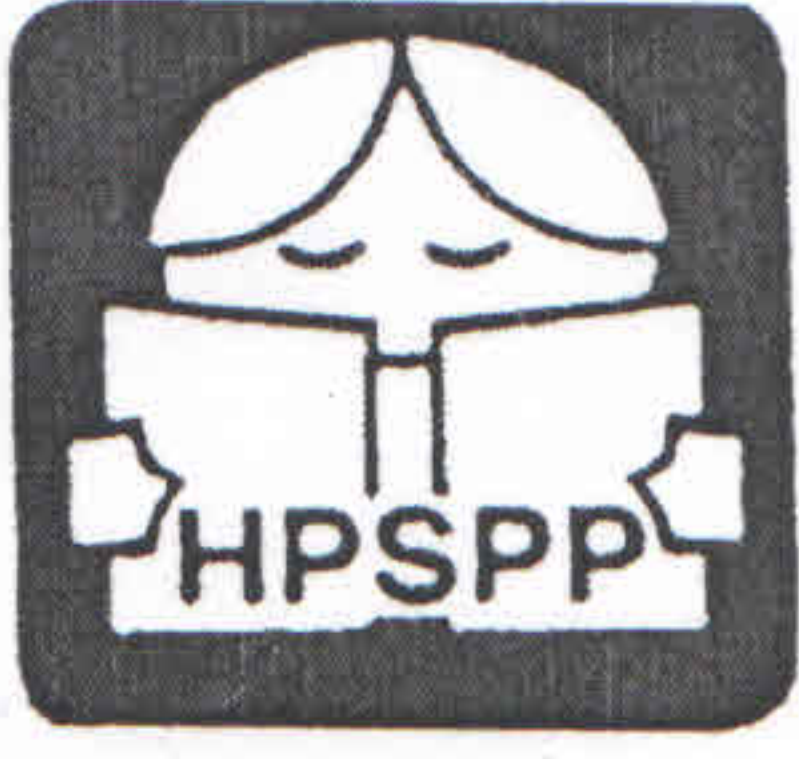

3. Efforts made by the faculty for the promotion of girl education through community mobilization, awareness- specify efforts and the no of Children enrolled through such efforts. – **25 marks**
4. Organizing special events to encourage participation of girls in curricular, extra-curricular activities excursion trips etc. etc. to be specified by the school. – **15 marks**
5. Activities organized through Meena Manch for the promotion of Girls education, their self-confidence, self-esteem, specify the activities organized and the impact. - **30 marks**
6. General cleanliness, up keep of the School conducive to teaching learning process, maintenance of girls toilets, Mid-day-meal kitchen. **20 marks**
7. Any special effort/intervention/contribution of the institution/ faculty for the promotion of Girl education. – **10 marks**

The award money to be given to the best school is to be utilized by assessing the special requirement of the school for the promotion of girl education through SMC and the procurement too to be made through SMCs by following financial rules.

Block Education Officers would send the list of best selected schools to the respective DPCs who in turn will send the consolidated list alongwith above details of best schools selected to H.Q.

As per the scheme, the award (Rs 10,000 each) to best selected schools will be given in the shape of items useful for the students and the school. Each best selected school will identify these items and the procurement shall be made through SMC by strictly following financial rules. A list of items identified by each selected best school should also be forwarded to H.Q. for record.

The process should be completed by the end of Nov., 2011.
